### Example #1: Meet John

John is a single man. He is a retired veteran with an income of **\$13,500**. He rents an apartment and takes several medications.

- Supplemental Nutrition Assistance Program (Formerly known as Food Stamps)
- Tax credit for the elderly and disabled
- Utility help program
- Home care services
- Prescription help
- Transportation service assistance





## Example #2: Meet Elizabeth

Elizabeth is a married woman. Together with her husband, they have a combined income of **\$40,000**. They own their home. She takes only a few medications. She is unable to work.

#### **Elizabeth might find help from:**

- Property tax relief program
- Home care assistance
- Utility help programs

You have the option to print either the Express or Comprehensive questionnaires. Fill it out and go back and enter responses.

## Here's what you'll need for your screening:


- Your ZIP code
- Your birthday and/or your spouse's birthday
- Where you live: house, apartment or mobile home
- How long have you lived there?
- Are you or your spouse a Veteran?
- Did you or your spouse ever work for the state, local, county or federal government or the railroads?
- What are the names of the medicines you take? (Have your medicine bottles or information with you.)
- How much money do you make in a month?
- What other expenses do you have (such as mortgage/rent, utilities, out-of-pocket medical bills, etc.)?
