Coverage Gap Stage

Beneficiaries reach the "Coverage Gap" stage when the amount paid for their out-of-pocket costs, are between \$3,701 and \$4,950

30 or 90-day supply, beneficiary pays:

Generic	No more than 58% of the cost
Brand	40% of the negotiated price

Catastrophic Coverage Stage

Beneficiaries reach the "Catastrophic" stage when the cost sharing amounts total \$4,951. This is the stage when the plan pays the most.

30 or 90-day supply, beneficiary pays:

Generic	Greater of \$3.30 or 5%
Brand	Greater of \$8.25 or 5%

Submission of Application

Agent Compensation



- \$71 for initial enrollments
- \$36 for plan changes or reenrollments
- Payments will no longer be prorated after the Annual Enrollment Period ends
- Brokers will be paid every month between the 15th & 25th
